The Pleasanton Chamber of Commerce's Business and Community Political Action Committee (BACPAC) recently completed its "Candidate Review" process. BACPAC made its endorsement recommendations for the 2024 General Election to the Chamber's Board of Directors for final consideration. These recommendations were approved at the most recent Chamber Board meeting. Candidates endorsed include those running for Pleasanton's Mayor, two City Council districts, and the Pleasanton School Board of Trustees.

BACPAC's Candidate Review process is comprised of three distinct steps: the Candidate Questionnaire, which is the first document submitted; the Candidate Interview, an individual interview with BACPAC; and the Candidate Forum, in which all candidates come together to answer questions on economic development and community vibrancy, as informed by the Chamber's public policy agenda. This local public policy platform lists goals for the economy, jobs, water, public safety, business formation, fiscal sustainability, and more.

After our lengthy Candidate Review process was completed and after further discussion by the Chamber Board, BACPAC and the Chamber's Board of Directors endorse the below candidates for office in the 2024 General Election, to be held Tuesday, November 5, 2024.

The Chamber and BACPAC extend our thanks and gratitude to all who participated in our Candidate Review process. We applaud those who raise their hand to serve our community. Public service is a critical part of our way of life. All community members have an opportunity to participate and make a difference, but only a few answer that call.
